## I. AIMS AND RATIONALE

It is Discovery Multi Academy Trust's ("the Trust") policy that all children shall wear full school uniform when attending school or when participating in a school-organised event, even outside normal school hours. The policy for the Trust's academies' school uniform is based on the notion that it:

- promotes a sense of pride in the school
- engenders a sense of community and belonging towards the school
- is practical and smart
- makes children feel equal to their peers in terms of appearance
- is regarded as suitable wear for school and is considered as good value for money by parents and carers
- is designed with health and safety considerations in mind

This school uniform policy is an integral part of the Trust's commitment to equality and inclusion. It allows pupils to establish a shared identity and to celebrate what they have in common, whilst continuing to be able to exercise their individuality and enjoy their diversity. All children are expected to adhere to the uniform policy.

When our academies have a 'mufti day', it is expected that pupils adhere to the policy for jewellery and footwear, in order to comply with Health \& Safety regulations. Other compulsory elements detailed overleaf will not apply on these days.

## 3. BEST VALUE CONSIDERATIONS

Our school uniform is available to order online from Tesco: My Clothing Limited, your premier school uniform supplier. This service enables parents and carers to order a variety of items of uniform embroidered with the school logo at a reasonable price and of good quality. This includes book bags, jumpers, rucksacks and cardigans.

The Board will review uniform suppliers periodically, to ensure that these items remain of good quality and available at a reasonable price for parents and carers.

## 4. SECOND-HAND UNIFORM

At the end of every half term any unclaimed lost property uniform in good condition will be washed then displayed in school and made available for parents to take home. An optional donation can be made, however, this is not a requirement.

## 5. PE REQUIREMENTS

For health and safety reasons, all children are required to wear a PE kit for all appropriate outdoor and indoor activities. For health and safety reasons, all pupils are required to remove earrings during PE lessons.

## 6. JEWELLERY, HEADWEAR AND MAKE-UP

Children may not wear jewellery to school at any time (except for small studs, which must be 5 mm in diameter or smaller, and watches) other than for religious of cultural reasons. Children in Foundation may not wear earrings in view of the physical aspects of their learning.

The 'Safe Practice in Physical Education and Sport' document is nationally accredited advice from the Association for Physical Education. This document, in addition to Devon Pedpass Safety Advice and the 'Health, Safety and Well-Being advice for Academies', states that all body piercings constitute an increased risk of injury in physical activity.

We do not allow headwear to be worn during class time or inside school buildings, except for religious or cultural reasons.

Children whose hair is shoulder length or longer should tie it back during school time where possible.

Hairclips and headbands should be plain and should not cause obstruction to anyone's learning, or cause distraction to any learner.

No make-up is to be worn, including nail varnish.

## 7. REASONABLE REQUESTS FOR VARIATION OF UNIFORM

The uniform policy has been adopted with the consideration for ethnicity, religion and belief and disability. Requests for variations to the school uniform which are directly related to particular established social, religious or cultural traditions, however, will be considered on an individual basis by the Senior Leadership Team. Legitimate requests for variation under health grounds will also be considered and will require medical evidence.

## 8. ROLE OF PARENTS AND CARERS

We expect parents and carers to support the school uniform policy. Children should come to school in uniform every day unless there are special circumstances, such as dressing up or charity fundraising days or events. Uniform should be kept clean and in good repair. Please label all children's clothing so that if lost, it may be reunited with its owner. Unlabelled, unclaimed uniform may be considered the property of the school and be donated, sold or otherwise disposed of.

## 9. ROLE OF THE ACADEMY

Non-compliance with the school uniform policy should be addressed immediately and by any member of staff in the following way:

In the first instance the class teacher or alternatively the school office will talk to the child regarding the explanation for non-compliance and any possible remedial action that might be required. At this stage, a letter will be sent home to parents/carers outlining what clothing item falls outside the policy.

Where there is continued failure to comply with the policy, parents/carers will be invited into school to meet with a member of the Senior Leadership Team to resolve the problem.

In accordance with Department for Education guidance, the school reserves the right to send a pupil home for a breach of uniform.

## 10. REVIEW

This policy will be reviewed every two years.
