Barriers to Learning

- A limited number of children have insufficient support at home to develop reading and mathematics skills.
- Lack of resilience and independence when faced with learning challenges.
- Low self-esteem from social and emotional issues impact on the ability of some children to self-regulate.
- Some children have less access to cultural and social experiences which would enhance their skills, knowledge and understanding.
- Lower attendance or punctuality due to issues arising from home circumstances.
- Disruption to learning and attendance due to national lockdown measures in place due to Covid 19.

Objectives

- I. To raise attainment and accelerate progress of those children at risk of underachieving in English and Maths at the end of their key stage.
- 2. To provide emotional and therapeutic support for children and skilled provision to support families.
- 3. To provide opportunities for children to participate in cultural experiences as part of a broad and rich curriculum.
- 4. To ensure disadvantaged children are supported to continue to narrow gaps due to disruption to learning due to Covid 19.

Outcomes

- Note that all statutory tests and assessments are cancelled due to Covid 19 in 2021.
- In EYFS to continue to narrow the gap between disadvantaged and other children in school-based assessments.
- At the end KSI to continue to narrow the gap between disadvantaged and other children in school-based assessments in reading, writing and maths.
- At the end KS2 to continue to narrow the gap between disadvantaged and other children in school-based assessments in reading, writing and maths
- Children have the opportunity to have educational workshops in school (or alternate virtual experiences) to broaden their cultural and social experiences. Where possible, the MAT Discovery List is used so that children have the opportunity to enhance skills, knowledge and understanding through engaging and inspiring activities (in line with Covid Risk Assessment measures).

• Trauma Informed Practice provides therapeutic and emotional support for the well-being of children and families. Vulnerable families are supported by school and the relevant services to ensure children are attending school regularly and are able to access learning and health support as appropriate.

This Pupil Premium Action Plan will be reviewed in July 2021.
